Superintendent Christopher Cowart said in a statement, "The School Board of Levy County believes the safety and security of students is paramount. Any allegations that are brought to School or District Staff are fully investigated and this allegation has been thoroughly investigated by our Human Resources Department. It was found to no merit, and this false accusation is an unfair claim against two people with spotless professional records."

Migrant Education Program: Lisa Custer with the Migrant Education Program showed a PowerPoint presentation about the program within Levy County. They assist students with student registration for college and transporting students when needed. For the 2021-2022 school year, they served 140 students in Levy County. They assist with backpacks, school supplies and community donated household goods such as clothing and shoes. They are a liaison with all schools and assist farmers with health fairs and COVID vaccines to workers. The main office is located in Gainesville, but Lisa Custer is located at the Cedar Key School.

<u>MOU Increasing Instructional Stipend Rates:</u> Kim Lake, Director of Finance, reviewed the MOU with the Board and explained the proposed increase in daily stipend rates. After discussion, Paige Brookins moved to approve the MOU, second by Cameron Asbell, motion carried.

Ashley Clemenzi said this has been a week of consequences and she is very disappointed with TV 20. She said the facts are abundantly clear that they are false and she is proud to be part of the Levy County School Board.
