



James Madison Preparatory High School 2020-2021 Off-Campus Lunch Policy

PURPOSE:

To give those 11th and 12th grade students (only) who have received parental consent as well as met school guidelines, the privilege to go off campus during the school's assigned lunch period

School Guidelines:

- Students **MUST** have a minimum 2.0 weighted GPA with no current "F's" and who have earned a minimum of 13 credits may apply.
- Off-Campus policy agreement must be signed by the parent/guardian or court ordered caregiver. The JMPHS Principal (or designee) must also sign the agreement.
- Agreement must be notarized by a certified notary

REGULATIONS:

- The school assumes no liability for any accident or injury incurred in the exercise of this agreement.
- Students who are approved for off-campus lunch privileges may leave campus at the start of the lunch period but must return in time for the next scheduled class.
- The off-campus pass is not valid for leaving campus early or arriving late. The pass does not excuse absences or tardies that occur for any class period.
- Students must sign out before leaving campus and sign in upon returning to campus. Failure to properly check out will be treated as skipping. This ensures accountability and failure to sign out and sign in may result in the loss of the off-campus privilege.
- During emergency situations, students must remain on campus until the situation is relieved.
- If a student falls ill during the lunch period and cannot return to school, the parent/guardian must notify the front office before 3:10 of that date. Upon return to school, the student must present a note to be excused from previous missed classes.
- Courteous behavior must be exercised by all students while off campus and out in the community. Students must obey all state, county, and city laws while off-campus. Failure to abide by state and community standards will result in loss of off-campus privileges.
- Loitering at, or in front of, public establishments and on private property immediately adjacent to school is prohibited.

GROUNDS FOR REVOCATION:

- Violation of previous regulations
- Three (3) tardies to the period immediately following lunch period (1 month loss of privileges)
- GPA falls below 2.0 or 1 “F” during the 9-week grading period (loss of privileges until academically eligible)
- Lunch Detention (loss of privilege until detention has been served.)
- Parent/Guardian may revoke at any time for any reason
- A complaint by any faction of the community against an individual
