#### **EXECUTIVE SESSION**

**Expulsion Hearing:** The Board heard information regarding a recommendation for expulsion. After school administrator Ms. Dee Westfall reviewed the evidence with the Board, the following actions were taken by the Board.

<u>Student 19-05</u>: (student and parents were present) After discussion from the Board Members, Brad Etheridge moved to approve the recommendation of the Superintendent to expel the student for the remainder of the 2018-2019 SY and 2019-2020 SY, with the opportunity to attend the WMHS FOCUS Center, must have clean monthly drug tests at parent's expense. Failure to comply with FOCUS rules or positive drug test will result in automatic removal from the Levy County School District, second by Paige Brookins, motion carried.

# REGULAR SESSION 6:00 p.m.

The School Board of Levy County met in Regular Session this 20<sup>th</sup> day of November, 2018 at 6:00 p.m. with Board Chairman Cameron Asbell, Brad Etheridge, Paige Brookins, Chris Cowart, and Board Attorney David Delaney, present.
