

NOTICE OF TAX FOR SCHOOL CAPITAL OUTLAY

The Suwannee County School Board will soon consider a measure to continue to impose a 1.500 mill property tax for the capital outlay projects listed herein.

This tax is in addition to the school board's proposed tax of 4.911 mills for operating expenses and is proposed solely at the discretion of the school board.

The capital outlay tax will generate approximately \$2,623,938 to be used for the following projects:

CONSTRUCTION AND REMODELING

- Classroom Additions to Existing Schools
- Administration Building Construction
- Plant Survey Construction Projects
- Land Acquisition
- Building Acquisition

MAINTENANCE, RENOVATION, AND REPAIR

- Reimbursement of the maintenance, renovation, and repairs paid through the General Fund as permitted by Florida Statute
- Facilities Maintenance and Improvement County Wide
- Roof Repairs and Replacement
- Renovation and Repair from Hurricane and Storm Damage
- Paving Parking Lots & Access Roads
- Storm Water Management
- HVAC/Fire Alarms/Sprinkler/Intercom/Security Systems/Energy Management
