PERFORMANCE RESPONSIBILITIES:

- (5) Provide Director, Maintenance with information needed to develop budget for fiscal year.
- * (6) Install all electrical systems in accordance with all codes (State and local).
- * (7) Install all electrical systems in accordance with blueprints, schematics and diagrams.
- (8) Supervise maintenance helpers / assistants to ascertain the work is in accordance with plans.
- (9) Assist other tradesmen and perform electrician duties in conjunction with other trades.
