*Individuals that were hired prior to July 1, 2013 and on R, S or T, as of 7/01/2013 will receive a longevity supplement.

Academic Summer School: Salary will be prorated to the hourly rate of the previous year.

Eleven Month Teachers: Pay shall be based upon 10 month instructional plus 20 days.

High School Guidance Counselors 11 Mo.

School Psychologist 11 Mo.

Annual contract teachers are eligible for performance pay and the amount of compensation will be negotiated and is based on the SBLC performance pay plan.
