- Must be able to participate in the Youth Tour day trips to Tallahassee Fl. on **February 20th & 21st**
- Must be able to ride in a car, bus and to fly in an airplane.
- Must be able to (and agree to) reasonably assist Tri-County Electric Cooperative in presentations promoting the Youth Tour program and the Cooperative, including a possible presentation at a local membership meeting, or the cooperative’s annual meeting and board meetings.
- The Cooperative reserves the right to select the runner up or another contestant for the Youth Tour trip if a winner is unable to participate.
- The winner’s parents/guardians must give the Cooperative written permission for the winner to participate on the Youth Tour.
- Must be a high school junior and the dependent of a TCEC member.
- Participants agree to receive and respond to communication via mail, telephone, social media, e-mail, or text message. If any of these communication avenues are not available to the participant they must notify the Cooperative.
- All material must be submitted by the indicated deadline and participants must arrive to all meetings and scheduled events on time.
