The School Board of Levy County met in Regular Session this 12th day of February, 2019 at 6:00 p.m. with Board Chairman Brad Etheridge, Paige Brookins, Chris Cowart, Cameron Asbell, Ashley Clemenzi and Board Attorney David Delaney present.

Adoption of Agenda: Chris Cowart moved to approve the agenda, second by Paige Brookins, motion carried.

<u>Welcome Visitors</u>: Board Chairman Brad Etheridge welcomed all the visitors and asked if anyone from the audience would like to address the Board. We had student visitors from Ms. Sherrie Schuler's class at BMHS. They introduced themselves and said they attended the meeting as a class assignment.

CTE Presentation: Mrs. Carol DuBois, Coordinator of Career Pathways / Literacy, gave an overview of CTE programs available to students within the Levy County schools. Students Will McCoy and Adam Sistrunk, FFA students and Ag members from WMHS, gave a PowerPoint presentation on Highland Hub Precision Agriculture and demonstrated how the technology works in the fields. Mrs. DuBois said this software is only at WMHS this year, but hope to expand the lease for other schools next year. Board Chairman Brad Etheridge said he uses this software program to assist with his fields. The Board thanked Ms. Shelby Rodgers and Austin Skipper, CTE Teachers for assisting with this new software program, all they do for the Ag Program. Mrs. DuBois said the Agriculture Program has one of the highest enrollment of the CTE Programs. Next, Mrs. DuBois introduced Mrs. Kelly Beauchamp, CMHS HOSA Advisor and CTE teacher and Carolyn Kohn, Health Academy student, who has earned her CNA license. Ms. Kohn said shared her experiences and gave a PowerPoint presentation about attending the four-week UF Health Care Summer Institute. Mrs. DuBois shared a graph with the Board showing comparisons in starting salaries for graduates with Bachelors Degree compared to CTE Industry Program Certificates, AS or AS Degrees. She thanked the Board for their support of the CTE Programs.

Strategic Planning: Superintendent Jeff Edison said the Strategic Plan for Levy County School District will be revised and will include the Board members on each committee. The committees are Student Achievement – Ashley Clemenzi, Human Resources – Cameron Asbell, Fiscal Resources – Brad Etheridge, Public Relations – Chris Cowart and Safe Schools – Paige Brookins. The committees will also include district staff, school administrators, teachers, parents and students. He said the District Instructional Team plans to have a new Strategic Plan within a few months for the Board to review and the Plan will be reviewed annually. Board Chairman Brad Etheridge commended Superintendent Edison for planning the future for Levy County School District with grassroots and including everyone.
